Removal of Breast Cancer Website and Related Webpages from within HHS's Office on Women's Health Website

Overview

The “Breast Cancer” website and related pages were removed from within the Department of Health and Human Services’ (HHS) Office on Women’s Health (OWH) website. While content about mammogram breast cancer screening remains, informational pages and factsheets about the disease, including symptoms, treatment, risk factors, and public no- or low-cost cancer screening programs, have been entirely removed and are no longer found elsewhere on the OWH site. Among the material removed is information about provisions of the Affordable Care Act that require coverage of no-cost breast cancer screenings for certain women, as well as links to a free cancer screening program administered by the Centers for Disease Control and Prevention (CDC). The office did not proactively announce or explain the removals.

These removals are part of wider changes to the OWH website that include the removal of resources related to lesbian and bisexual health, minority women’s health, and other topics. See the “[Overview of HHS’s Office on Women’s Health Website Overhaul](#)” report, also documented in the [Appendix](#) below.

Background

Agency details: OWH was established in 1991 within HHS’s Office of the Assistant Secretary of Health. According to the [OWH website](#), the office “coordinates women's health efforts across HHS and addresses critical women's health issues by informing and advancing policies, educating health care professionals and consumers, and supporting model programs.”

Communications about changes: The office has not proactively communicated about or explained the changes described within this report.

Known archives: A public Web archive for the [www.womenshealth.gov](#) domain, collected by the Federal Depository Library Program Web Archive, can be found at https://wayback.archive-it.org/4438/*/https://www.womenshealth.gov/. The materials can be found by navigating from the HHS archive at the URL <https://archive.hhs.gov>. The OWH website does not link to these archives and does not explain how to navigate to these archives. These archives are also incomplete and do not contain website snapshots pertaining to the dates of many of the changes detailed within this report.

Description of Most Notable Changes

1. The “Breast Cancer” website and related pages were removed between June and December 2017 from within OWH’s website. The [main page](#) at the URL <https://www.womenshealth.gov/breast-cancer/> ([Webpage 1](#)) links to six corresponding informational pages at the “/breast-cancer” subdomain, all of which were removed ([Table 1](#)).

- a. All seven pages on the OWH “Breast Cancer” website currently redirect to the [OWH home page](#), which contains no information related to breast cancer.
 - b. The main page on the “Breast Cancer” website served as a repository of links to pages on the “Breast Cancer” website, as well as other breast cancer information on the OWH site and other government sites. The page previously linked to informational pages such as [“Breast cancer symptoms”](#), [“Screening and diagnosis...”](#), [“Breast cancer risk factors and prevention”](#), and [“Government in action”](#), all of which have been removed ([Table 1](#)). Among other resources, the page linked to factsheets on [“Early-stage breast cancer treatment”](#) and [general breast cancer information](#), both of which have been removed ([Table 2](#)).
 - c. The main page contained a link to a [Spanish language version](#) of the “Breast Cancer” main page, which was also removed.
 - d. A link that previously led to the “Breast Cancer” page from OWH’s [“A-Z Health Topics”](#) page has been removed (see [Appendix](#)).
2. An informational page on [“Mammograms,”](#) separate from the “Breast Cancer” website is still live on the OWH site, containing information about common screening procedures ([Webpage 3](#)).
 - a. Although the [“Screening and diagnosis...”](#) page ([Webpage 2](#)) that was part of the “Breast Cancer” website now redirects to the “Mammograms” page, a significant amount of content has been removed and is not included on the “Mammograms” page or elsewhere on the OWH website.
 - b. Links to the removed breast cancer informational pages were removed from the “Mammograms” page.
 3. Information about laws and government programs pertaining to breast cancer related health insurance coverage and related pages have been removed from OWH’s website:
 - a. The removed [“Screening and diagnosis”](#) page prominently featured information about provisions of the Affordable Care Act that require insurers to cover mammograms for certain women at no cost ([Webpage 2](#)).
 - b. The “Screening and diagnosis...” page linked to a PDF [“Screening Tests for Women”](#), which has also been removed, and stated that “Insurance companies are required to cover many [preventive services for women](#) at no cost to you because of the [Affordable Care Act.](#)” Some of the PDF’s content can be found on the live [“Steps for better health by age”](#) pages, but no breast cancer information is currently presented for any age group on those pages ([Webpage 2](#)).
 - c. The removed [“Government In Action”](#) page contained information on the National Breast and Cervical Cancer Early Detection Program, a CDC program that offers screening to “low-income, uninsured, and underinsured women” ([Webpage 4](#)).
 4. The changes described above are part of a broader pattern of changes to the OWH website, detailed more extensively in the [“Overview of HHS’s Office of Women’s Health Website Overhaul”](#) report and documented in the [Appendix](#) below.

Information about removed content on the “Breast Cancer” main page

1. The main page of OWH’s “Breast Cancer” website was removed between [June 27, 2017](#) and [December 11, 2017](#).
2. The main page URL <https://www.womenshealth.gov/breast-cancer/> currently redirects to the OWH homepage ([March 26, 2018](#)).
3. While the main page hosted little informational content itself, it contained the following sections with links to corresponding informational resources:
 - a. “Topics” (See [Table 1](#) below for assessment of access to pages corresponding to links listed in this section).
 - b. “Features” (**Note:** Access to pages and content corresponding to links listed in this section are not evaluated in this report).
 - c. “Fact sheets” (See [Table 2](#) below for assessment of access to pages corresponding to links listed in this section).
4. The page contained a link to a Spanish language version of the “Breast Cancer” main page, which was removed between [February 6, 2017](#) and [April 27, 2017](#). (**Note:** The change in access to the removed Spanish language page and to its content is not evaluated in this report)

1. The "Screening and diagnosis" page was removed between [June 28, 2017](#) and [March 9, 2018](#).
2. The page URL <https://www.womenshealth.gov/breast-cancer/screening-diagnosis-mammogram-breast-exam/index.html> redirects to the OWH "Mammograms" page ([March 9, 2018](#); [Webpage 3](#)).
3. The page contained the following sections (*Note: access to content linked from these sections has not been evaluated comprehensively*):
 - a. "Breast cancer screening"
 - i. This section contained information about various breast cancer screening methods, including "Mammogram" and "Clinical breast exam (CBE)."
 - ii. The link "[womenshealth.gov screening charts](#)" previously led to a PDF titled "Screening Tests for Women", which has now been removed. The removed PDF detailed guidelines "about important screening tests for women" and mentioned that "Insurance companies are required to cover many [preventive services for women](#) at no cost to you because of the [Affordable Care Act](#)." Some of the "screening chart" content can be found on the live "[Steps for better health by age](#)" pages, but no breast cancer information is currently presented for any age group on those pages.
 - iii. A text box labelled "Related information" prominently featured a notice about "no-cost" breast cancer screenings, which insurers are required to provide certain women under provisions of the Affordable Care Act. The text box stated in part: "Some women have not gotten regular mammograms in the past because of cost and lack of insurance. But

insurance companies are now required to [cover mammograms](#) every 1 to 2 years for women over 40 at no cost to the patient because of the [Affordable Care Act](#).”

- b. “Diagnosing breast cancer”
 - i. This section contained information on various diagnostic methods: “diagnostic mammogram”, “ultrasound exam”, “magnetic resonance imaging (MRI)”, and “breast biopsy”.
- c. “More information on Screening and Diagnosis”
 - i. This section contained links to: relevant OWH fact sheets; other federal websites with information on federally subsidized free and low-cost cancer screenings; websites for nonprofit organizations that provide support for patients diagnosed with breast cancer; and other informational resources.

Information about changes to content on "Mammograms" page

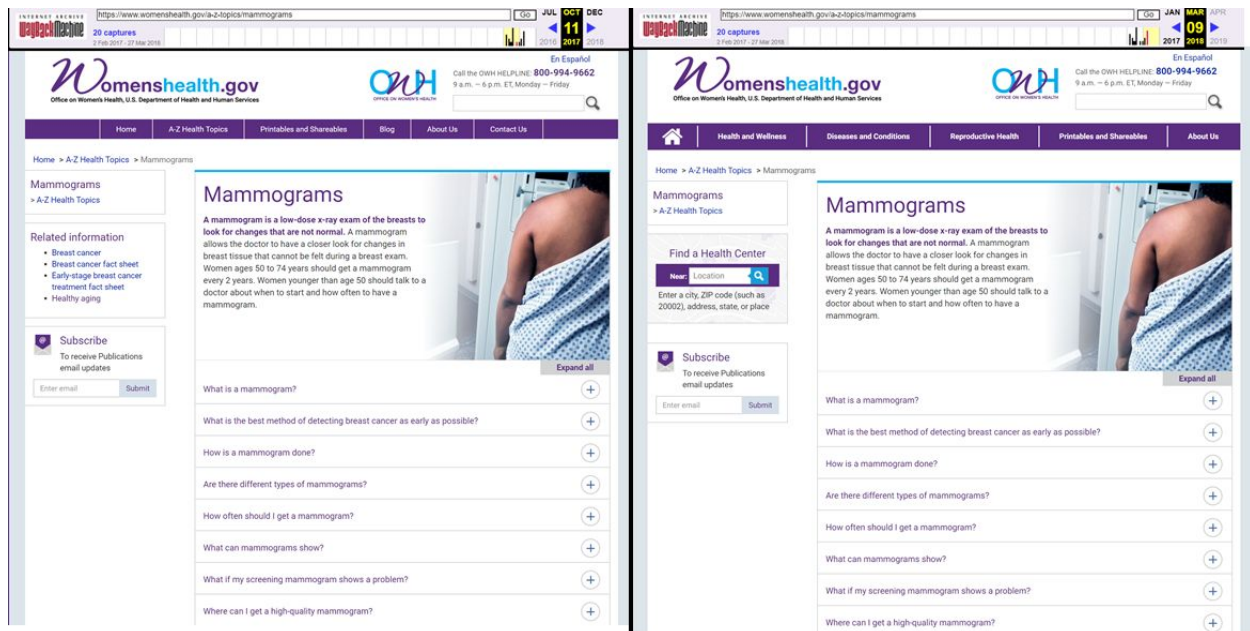
1. The "Mammograms" page, which was outside of the OWH's "Breast Cancer" website, was changed between [October 11, 2017](#) and [December 21, 2017](#). Changes include:
 - a. Removal of "Related information" section from the page's sidebar, which included links to:
 - i. [Breast cancer](#) (*Note: this is a link to the OWH's "Breast Cancer" website*)
 - ii. [Breast cancer fact sheet](#)
 - iii. [Early-stage breast cancer treatment fact sheet](#)
 - iv. [Healthy aging](#)
 - b. Changed "Office on Women's Health is grateful for the additional reviews" to "Office on Women's Health is grateful for the medical review in 2013"
 - c. Removed phrase "Content last reviewed: June 10, 2013." No "Content last reviewed" date is currently presented.
2. A page titled "Mammograms fact sheet" was previously hosted at the URL <https://www.womenshealth.gov/publications/our-publications/fact-sheet/mammograms.html>. The URL began redirecting to the currently live "Mammograms" page at the URL <https://www.womenshealth.gov/a-z-topics/mammograms> between [December 8, 2016](#) and [January 7, 2017](#). *Note: The text and links are almost entirely unchanged between these two versions, although the formatting and overall presentation has been altered. A systematic analysis evaluating the differences in content and difference in access to these pages from the rest of the website has not been performed.*
3. The page contains explanatory information answering questions like "What is a Mammogram," guidelines on when and how often women should undergo mammograms, and other information related to the subject.

Information about redirect from the "Screening and diagnosis..." page ([Webpage 2](#)) to the "Mammograms" page ([Webpage 3](#)) and comparison of pages

1. The previous URL for the "Screening and diagnosis..." page that was removed with the "Breast Cancer" website began redirecting to the "Mammograms" page between [June 28, 2017](#) and [March 9, 2018](#).

2. In contrast to the “Screening and diagnosis...” page ([Webpage 2](#)), this page does not specify or mention:
 - a. Links to general breast cancer information.
 - b. The fact that insurers are required to cover “no-cost” screenings for certain women under the Affordable Care Act (ACA).

Information about removed content on the "Government in action on breast cancer" page

1. The "Government in action on breast cancer" page was removed between [October 10, 2017](#) and [March 9, 2018](#).
2. The page URL <https://www.womenshealth.gov/breast-cancer/government-in-action/index.html> redirects to the OWH homepage ([March 9, 2018](#)).
3. The page contained the following sections:
 - a. "National Breast and Cervical Cancer Early Detection Program" (NBCCEDP)
 - i. This section contained information on federal programs that provide free or low-cost cancer screening, including clinical breast exams and mammograms. Funded by the CDC, NBCCEDP offers screening to "low-income, uninsured, and underinsured women."
 - ii. This section also notes that all 50 states and the District of Columbia have approved an "option to offer women in the NBCCEDP access to treatment through Medicaid."
 - b. "National Cancer Institute's Cancer Information Service"

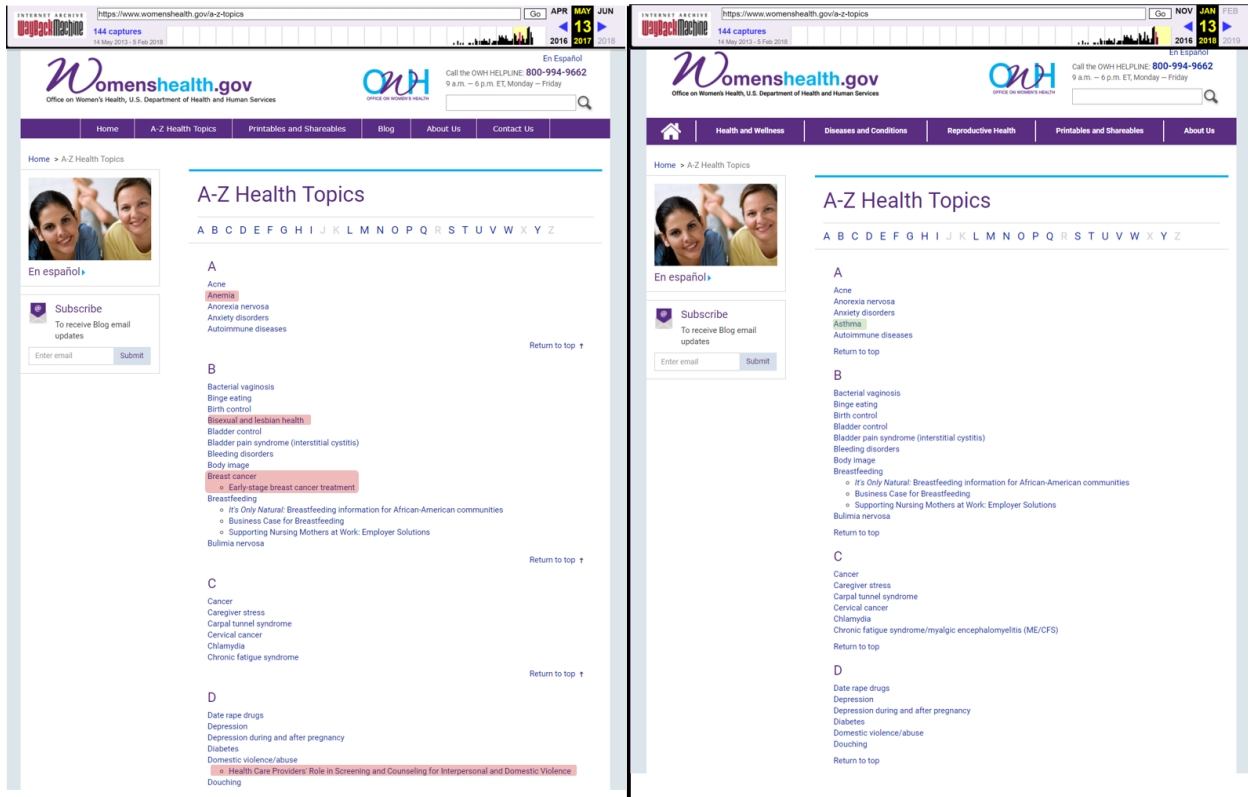

This section is devoted to comparing the OWH website’s previous and current repository of fact sheet and other resource links. The repository was moved from the “ePublications” page to the “Fact sheets” page:

The information below is not intended to be a comprehensive analysis of the changes made to the repository or access to resources linked from the repository, but is rather intended to provide context for changes to some of links described in [Webpage 1](#). Specific information about fact sheets and other resources that have been removed from the OWH website will be detailed in future reports about those specific parts of the website.

Information about the “ePublications” page

1. The “[ePublications](#)” page was a repository of informational fact sheets about women’s health topics organized by 22 broad health categories.
2. Each broad health category section listed links that led to pages with informational text about the corresponding health topic. Some links appeared under multiple categories. The URLs for these pages, which were referred to as “fact sheets” corresponded to the “womenshealth.gov/publications/our-publications/fact-sheet/” subdomain. Each fact sheet page had a link to a PDF containing the same or similar content to the informational text on the page.
3. There were also links on the page, found by clicking on drop-down sections within each health category, with URLs that led to PDFs. The URLs corresponded to the “womenshealth.gov/files/assets/docs/” subdomain. Some of the corresponding PDFs were factsheets, while others provided informational charts. For some, but not all of these resources, there were links corresponding to both an English and Spanish language version of the PDF. These PDFs are no longer live at the previous URLs, however a comprehensive analysis has not been conducted to determine if the content can be found elsewhere on the OWH website.

Information about the “Fact sheets” page

1. The “[Fact sheets](#)” page links from the OWH website’s “Printables and shareables” menu item, and is the current repository of informational fact sheets about women’s health

topics organized by 14 broad health categories. The repository was first stored on the Internet Archive's Wayback Machine on [April 27, 2017](#).

2. Under each broad health category section, there are links that correspond to PDFs with informational text about the health topics. The URLs for these pages correspond to the "womenshealth.gov/files/documents/" subdomain.
3. On [April 27, 2017](#), there were no links to Spanish language PDFs. Since then, the number of fact sheet links has increased and each fact sheet now has a corresponding link to both an English and a Spanish language PDF.

Information about move from the "ePublications" page to the "Fact sheets" page

1. Between [April 26, 2017](#) and [May 13, 2017](#), the "ePublications" URL, <http://womenshealth.gov/publications/our-publications/index.html>, began redirecting to the "Printables and Shareables" URL, <https://www.womenshealth.gov/printables-and-shareables>, and the "ePublications" page was removed from the OWH website. The "Printables and Shareables" page leads to the "Fact sheets" page via the "Browse by resource" link or icon.
2. Some health categories that were on the "ePublications" page have been removed, such as "[Healthy aging](#)" and "[Sleep disorders](#)." Some categories have remained the same, such as "Pregnancy" and "Reproductive Health." Other health categories have been added to "Fact sheets" that were not previously on "ePublications," such as "Breastfeeding" and "HIV and AIDS" (see Screenshot 2).
3. Some resources listed in the repositories have remained the same, although some have been moved to different health categories on the "Fact sheets" page. For example, "[Bacterial vaginosis](#)" ([April 26, 2017](#) version) has moved from "Reproductive health" to "Sexual health" section. Other resources have been removed from the repository, such as the "[Date Rape Drugs Fact Sheet](#)," whose URL now redirects to a related page, and the "[Lesbian and bisexual health fact sheet](#)" (see "[Removal of Webpage and Corresponding Links Pertaining to Lesbian and Bisexual Health from HHS's Office of Women's Health Website](#)" report).
4. For some of the health topics that correspond to link URLs listed on the "ePublications" page, but removed from the "Fact sheets" page, there are different pages that are still live with the same or similar content. For example, the "[Depression During and After Pregnancy](#)" page was previously listed under the "Pregnancy" section, but a page with the same content can now be found on the "A-Z Health Topics" page.
5. For health topic fact sheets that are still associated with live pages, the corresponding previous "womenshealth.gov/publications/our-publications/fact-sheet/" subdomain URLs now redirect to new pages with the same or similar content corresponding to "womenshealth.gov/a-z-topics/" subdomain URLs. (See [Table 1](#) and "Additional Notes for Table 1" above for examples of redirects.)
6. Pages corresponding to "womenshealth.gov/files/assets/docs/" subdomain URLs, linked from the drop-down sections on the "ePublications" page, appear to have been removed. The existence of similar or identical content elsewhere on the OWH website has not been evaluated.
